




Introduction

NuPrime PRA-9X is a pre-amplifier with a fully balanced design and includes a MM phono input. The input and output use a special audio Relay Switch, which has the lowest interference and highly accurate transmission, to switch the source.




The phono input has a variety of settings for input resistors and capacitors to match different MM cartridges. PRA-9X phono amplifier is a 2-stage RIAA amplifier that utilises NJR MUSES8820 audio quality op-amp to provide an accurate RIAA curve and low distortion at high amplification and performance.





Line Outputs include four NuPrime's new ultra-low distortion amplifier modules (THD=0.0004%) composed of MUSES8820 op-amp in a new amplifying circuit. It has excellent ultra-low distortion and high driving force characteristics.

1. LP vinyl RIAA phono amplifier circuit, with adjustable input capacitance and impedance.
2. Input and output fully balanced preamp.
3. Utilizing the MUSES 8820 bipolar-input dual op-amp module, PRA-9X can reproduce the presence of an orchestra as experienced in a symphony concert and the breathing sound of a player in a live music house.
4. Nuprime's next-generation current booster circuit, providing top 0.0004% (7.5Vrms) THD performance and 114db signal-to-noise ratio (S/N).
5. High-performance headphone amp output.
6. Input and output Trigger for power on/off control of multiple devices.



Front Panel



1 Power / Input Selector:

Briefly press for 3 sec to On/Off standby mode
Turn the knob to switch between inputs

2 Standard 6.3mm (1/4") stereo headphone jack

3 Remote IR receiver

4 Display

5 VARIABLE: volume can be adjusted FIXED: The output is at half volume and can't be adjusted.

6 Volume control:

Turn the knob clockwise to increase volume
Turn the knob counterwise to decrease volume
Briefly press the knob to Mute / un-Mute








AC Inlet : Connect the supplied mains lead to the AC IN (115V or 230 V) terminal on the rear of the PRA-9X.



ADDITIONAL RIGHTS

For consumers, who are covered by consumer protection laws or regulations in their country of purchase or, if different, their country of residence, the benefits conferred by this warranty are in addition to all rights and remedies conveyed by such consumer protection laws and regulations. This warranty does not exclude, limit or suspend any rights of consumers arising out of nonconformity with a sales contract. Some countries, states and provinces do not allow the exclusion or limitation of incidental or consequential damages or allow limitations on how long an implied warranty or condition may last, so the limitations or exclusions described below may not apply to you. LIMITED WARRANTY

For a period of ONE (1) YEAR from the date of retail purchase by the original end-user purchaser ("Warranty Period"), NuPrime warrants (in) this product against defects in materials and workmanship, and (ii) that each Product, unmodified and under normal use and conditions, will substantially comply with NuPrime' applicable written technical documentation for the Product. NuPrime reserves the right to make substitutions and modifications from time to time in the specifications of Products sold by NuPrime, provided that such substitutions or modifications do not materially affect overall Product performance.

If a hardware defect exists and a valid claim is received within the Warranty Period, at its option and to the extent permitted by law, NuPrime will (1) repair the hardware defect at no charge, using new or refurbished replacement parts, (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product. NuPrime may request that you replace defective parts with user-installable new or refurbished parts that NuPrime provides in fulfillment of its warranty obligation. A replacement product/part assumes
